Dear Participant:

The recently negotiated Collective Bargaining Agreement provides for the following improvements made to the **Dental Plan of the Elevator Division**. Please note that the effective dates of the changes vary. All changes have been approved by the Trustees of the Plan.

**Interceptive orthodontics covered up to \$700 and dental implants will be covered up to \$900 effective May 1, 2015.**

Annual maximums and limits (including orthodontics) remain unchanged.

**Effective Immediately: Dental coverage is extended for full-time dependent students from age 25 to age 26.**

All full-time dependent students will be covered for dental benefits up to age 26 upon receipt of a letter from the college registrar.

**The Dental Schedule of Benefits will be increased by 10% effective May 1, 2015.**

Annual limits and maximums (including orthodontics) remain unchanged.

**Coverage for eligible participants who are unemployed and available is extended up to 39 weeks.**
