Important Notice Regarding the following:

- 1. "A"-Rated Dues Assessment Salary Deduction**
- 2. ADM & Expeditors Annuity Fund Contribution changes**
- 3. Electrical Employers Self Insurance Safety Plan Increase**

Effective July 28, 2016, week ending August 3, 2016, week #31:

- 1 The dues assessment deduction for A-rated journeypersons, and above, will be increased to 1.5% from the current 1%. This amount will continue to be remitted to the Joint Industry Board as part of the weekly payroll.
- 2 The additional \$.50 per hour Annuity Fund contribution for the Administrative ("ADM") and Expeditors' Divisions will be converted to \$4.00 per day as follows:
 - a. ADM:
 - More than 12 months and up to 24 months-\$13.25 per day
 - More than 24 months and up to 36 months-16.75 per day
 - More than 36 months-\$23.25 per day
 - b. Expeditors:
 - \$25.00 per day
- 3 Electrical Employers Self Insurance Safety Plan:
 - a. Electrical Wiring is increased from 7.05% to 7.99%. (The wrap-up rate remains at 1.885%)
 - b. ADM rate is increased to .63%
