One of the cherished benefits offered by the Educational and Cultural Trust Fund of the Electrical Industry is CAMP INTEGRITY. In 1971, our Trustees, recognizing the important contributions camp can make in the growth and development of our children, built CAMP INTEGRITY on the shores of Southampton, Long Island. This year, we are pleased to offer and present CAMP INTEGRITY AT REDWOOD at our new location in Walden, New York.

Since that first summer in 1972, over 22,048 children have enjoyed an educational program while simultaneously experiencing the spirit of adventure in natural surroundings - all under an umbrella of safety. Learning new skills, developing leadership abilities, gaining a greater sense of responsibility, and improving your child's self-image are some of the goals of the CAMP INTEGRITY AT REDWOOD Staff.

While your child may initially find themself surrounded by "strangers", they will quickly learn that, in camp life, many campers become life-long friends. The fact that all worthwhile relationships are based upon trust, shared experiences, and mutual respect enables them to quickly become accustomed to their new surroundings and develop strong bonds with their fellow campers.

The Officers of Local Union No. 3, I.B.E.W., and the Trustees of the Educational and Cultural Trust Fund of the Electrical Industry maintain a high level of interest and supervision in the program and the facilities of the camp. Improvements and safety measures are constantly being implemented. Now, more than ever.

# PROGRAMS

CAMP INTEGRITY AT REDWOOD'S programs have been designed to develop each child's mental and physical growth. Your child will participate in such activities as softball, soccer, volleyball, lacrosse, archery, swimming, rowing, canoeing, cooking, first-aid, games, skits, handcrafts and nature walks. Each program activity is crafted to strengthen the development of important skills and concepts, such as coordination, concentration, creativity, and team effort, and enhance the important life-qualities of self-confidence and self-discipline.

The Aquatics program helps our campers develop their capabilities and self-assurance in water. Swimming instructions and games, as well as recreational swimming activities, are regularly held at the camp. During swim training sessions, our instructional Staff will focus on teaching the proper swimming strokes on the drown-proof float. At our boating area on the lake, row-boating and canoeing instructions are enjoyed by the campers while they hone their waterfront skills.

Programs in arts, crafts, and drama enable campers to enhance their abilities or develop hidden talents that they may not be otherwise aware of. Our campers have shown in the past that they can, with guidance, greatly expand their ingenuity and, with patience and motivation, grow their creative talents.

At CAMP INTEGRITY AT REDWOOD, we want our campers to appreciate the outdoors. We strive to provide them with enough practical knowledge and confidence to take care of themselves in the woods. It is equally important to teach that they exist in a delicate balance with nature, and that we can, by a careless action or neglect, destroy our environment.

## <u>STAFF</u>

Throughout the years, most of our Staff have been the sons and daughters of members of the industry. Counselors are selected to join the Staff because of their sincere interest in working with young people and prior experience in the various camp program areas. The Staff has all necessary certifications required by New York State Public Health regulations and must successfully complete pre-camp training courses.

We continue to be very proud of our camp Staff's dedication to the principles and philosophies of CAMP INTEGRITY AT REDWOOD. Our Staff will always ensure that each camper receives the full benefit of camp life, is never neglected or underestimated, and, most importantly, has fun!

## **CAMPER ELIGIBILITY**

Eligibility is based on one parent being a participant in the Educational and Cultural Trust Fund of the Electrical Industry. The child must be at least eight (8) years of age when he or she arrives at camp, and not have reached their 16th birthday by the end of the camp session. There are separate sessions for boys and girls. Each camp session is fourteen (14) consecutive days.

# **RESERVATIONS**

If you are interested in having your child take part in CAMP INTEGRITY AT REDWOOD this 2021 season, please complete the enclosed application as directed and the signed COVID-19 Assumption of Risk form, and return it with your check or money order for two hundred and forty dollars (\$240.00), <u>made payable</u> to "CAMP INTEGRITY", to cover the camp registration fee for a fourteen-day session for each child. This fee only represents a small portion of the total cost of the operation of CAMP INTEGRITY AT REDWOOD. # MEALS

The camp has a modern kitchen which provides a healthy, balanced and appetizing menu that meets all of the daily nutritional and dietary needs of very active children. Individual medical or dietary accommodations, restrictions, or requests, aside from regular medications, requires prior notification.

# HEALTH AND SAFETY

Each year, the camp passes several inspections by the New York State Health Department. Every effort is made to provide a healthy and safe environment for campers and Staff. As a mutual precaution, each camper must have a medical examination and medical history taken prior to arrival at camp. This must be sent to CAMP INTEGRITY AT REDWOOD at least ten (10) days <u>before</u> the camper's arrival.

#### COVID-19

In the wake of the extraordinary COVID-19 pandemic, CAMP INTEGRITY AT REDWOOD will strive to maintain a safe and healthy environment for its campers and Staff this 2021 season. Accordingly, the camp is implementing additional safety measures to protect campers and Staff from contracting and spreading COVID-19 pursuant to New York State Department of Health and Centers for Disease Prevention and Control ("CDC") guidelines.

This 2021 season, campers and Staff will be pre-screened upon arrival by the camp's Health staff when entering the camp. Evidence of negative test (PCR within 72 hours) or vaccination will be collected and required at this time.

In addition to observing strict pre-screening health and temperature check protocols, hygiene, sanitizing, and physical distancing requirements, CAMP INTEGRITY AT REDWOOD will operate at half capacity and all <u>Staff</u> shall be vaccinated against COVID-19. Campers will also be formed into "cohorts" of ten, which will participate in all activities together with minimum exposure to other camper cohorts. For sleeping, each camper cohort will be further divided into separate bunks of no more than 5 campers each to remain safely distanced.

All parents and guardians must be ready, willing, and able to of COVID-19 or positive COVID-19 test.

CAMP INTEGRITY AT REDWOOD'S <u>on-site</u> Health Director and nursing staff will also be available at all times to respond to any COVID-19 concerns and answer any questions.

## PERSONAL GEAR

CAMP INTEGRITY AT REDWOOD provides a bunk, mattress and foot-locker for your child's use while at camp. Parents <u>must</u> provide personal clothing, blankets, pillows, pillowcases, and sheets. Each article of clothing and belongings must have the campers name marked on it so that such items can be returned. Electronic equipment, radios, CD players and expensive clothing are not appropriate and should not be brought to camp. A list of clothing and other items needed for camp will be provided along with the camp confirmation.

## LEAVING CAMP

All departures from CAMP INTEGRITY AT REDWOOD are on **SATURDAY**. Camper pickup may start at 8:00 a.m., when the camper sign-out process begins. The camper <u>must</u> leave camp before 11 a.m. so that the camp can timely prepare for the next session of incoming campers. Due to this schedule, no departing campers can stay or remain after 11 a.m.

#### **CELL PHONE POLICY**

To fulfill the spirit and mission of CAMP INTEGRITY AT REDWOOD and your child's immersion in natural surroundings, campers may <u>not</u> bring or use any cell phones or devices capable of utilizing the internet.
