ASSUMPTION OF RISK AND WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

COVID-19 has been declared an emergency by the Centers for Disease Prevention & Control (“CDC”) and New York State Department of Health (“DOH”). COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend physical distancing and additional safety measures to prevent the spread of COVID-19.

While CAMP INTEGRITY AT REDWOOD (“CAMP INTEGRITY”) has implemented preventative measures to reduce the spread of COVID-19 at CAMP INTEGRITY this 2021 season in accordance with CDC and DOH guidelines, including, but not limited to, strict pre-screening health and temperature check protocols, hygiene, sanitizing, physical distancing requirements, reduced capacity and mandatory COVID-19 vaccinations for its Staff, CAMP INTEGRITY cannot guarantee that you, your children, or any other person, will not become infected with COVID-19 while your child(ren) attend CAMP INTEGRITY during the 2021 season. Furthermore, while CAMP INTEGRITY has put every effort into maintaining a safe environment, your child attending CAMP INTEGRITY could increase your child(ren)’s risk of contracting and transmitting COVID-19, including to you and/or members of your household.

By signing this agreement, you acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that your child or children and yourself or your family or household may be exposed to or infected by COVID-19 by your child(ren)’s attendance at CAMP INTEGRITY this 2021 season, and that such exposure or infection could result in personal injury, illness, permanent disability, or death. You understand that the risk of becoming exposed to, or infected by, COVID-19 through CAMP INTEGRITY may result from the actions, omissions, or negligence of your child(ren) and others, including but not limited to CAMP INTEGRITY employees, volunteers, and program participants. You voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to your child or children or yourself or your household members, including, but not limited to, personal injury, disability, death, illness, damage, loss, claim, liability, or expense or any kind, that you or your child(ren) may experience or incur in connection with your child(ren)’s attendance at CAMP INTEGRITY, including its activities or programming. On your own behalf and on behalf of your child(ren), you hereby release, covenant not to sue, discharge, and hold harmless and will indemnify CAMP INTEGRITY, the Educational & Cultural Trust Fund of the Electrical Industry, Local Union No. 3, International Brotherhood of Electrical Workers, AFL-CIO, E & C Property Holdings North, Inc. and their respective affiliates, employees, agents, Trustees, directors, and representatives, of and from any and all claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. You expressly understand and agree that this release includes any claims based on the actions, omissions, or negligence of CAMP INTEGRITY and Educational & Cultural Trust Fund of the Electrical Industry, their employees, agents and representatives, whether a COVID-19 infection occurs before, during, or after participation in the CAMP INTEGRITY 2021 season.

You further expressly agree that you are ready, willing, able, and shall pick up your child(ren) within 24 hours upon receiving notice that your child exhibits any COVID-19 symptoms or tests positive for COVID-19.
