Dear Participant:

The Trustees of the Dental Benefit Plan of the Elevator Industry recently approved the following changes to the dental benefit coverage effective July 1, 2024.

- Increase the dental benefit coverage allowances by 20% for implants and associated services, periodontal related services, and endodontic therapy.
- Provide coverage for previously excluded services which include:
 - General anesthesia;
 - Re-treatment of root canals;
 - Core build-up;
 - Guided tissue regeneration;
 - Cone beam CT scan;
 - Mouth guard

Your provider should continue to submit a pre-determination of benefits and always contact Anthem Blue Cross and Blue Shield or DDS, Inc. for verification of covered services.
