WAIVER AND RELEASE OF LIABILITY

READ BEFORE SIGNING

In consideration of being allowed to participate in any way in the Educational and Cultural Trust Fund of the Electrical Industry's CAMP INTEGRITY AT REDWOOD 2025 season, including, but not limited to, its athletic sports program, related events, and activities, the undersigned acknowledges, understands, and agrees that:

- 1. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment, and personal discipline may reduce this risk, the risk of serious injury does exist; and,
- 2. I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS, BOTH KNOWN AND UNKNOWN, even if arising from the negligence of the Releasees or others, and assume full responsibility for my child's participation; and,
- By signing this agreement, while I understand that CAMP INTEGRITY AT REDWOOD has implemented preventative measures to reduce the spread of COVID-19 this 2025 season in accordance with CDC and New York State DOH guidelines. I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child or children and I or my family or household may be exposed to or infected by COVID-19 by my child(ren)'s attendance at CAMP INTEGRITY AT REDWOOD this 2025 season, and that such exposure or infection could result in personal injury, illness, permanent disability, or death; and,
- 4. I willingly agree that my child shall comply with the stated and customary terms and conditions for participation. If, however, my child observes any unusual significant hazard during his or her participation, he or she will be responsible for removing himself/herself from participation and bring such to the attention of the nearest official immediately; and,
- I, for myself and on behalf of my child, heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS the Educational & Cultural Trust Fund of the Electrical Industry, Camp Integrity at Redwood, Local Union No. 3, International Brotherhood of Electrical Workers, AFL-CIO, E & C Property Holdings North, Inc., Joint Industry Board of the Electrical Industry and their respective affiliates, employees, agents, Trustees, directors, and representatives (the "RELEASEES"), WITH RESPECT TO ANY AND ALLINJURY, DISABILITY, DEATH, CLAIMS OR LOSS OR DAMAGETO PERSON OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
